In consideration of Wendy Lou Ranch, Inc. and Wendy Lou Classic Game Reserve (collectively "Wendy Lou") allowing the undersigned to engage in hunting and other recreational activities upon the property of Wendy Lou, the undersigned agree to the following:

1. *Assumption of Risks:* The undersigned acknowledges that (A) dangerous natural or man-made conditions may exist or occur on the premises or in connection with the fixtures, equipment, vehicles, and other personal property of Wendy Lou, including streams and rivers with currents and water that may be deep or flood, hazardous driving and walking conditions, uneven terrain, the presence of wild, domestic, poisonous, or diseased animals, elevated hunting stands, and/or camouflaged sunken hunting blinds; and (B) hunting is an inherently dangerous activity involving the use of firearms and other lethal implements and the presence of other hunters. The undersigned assumes all such dangers and risks.

2. *Indemnity:* The undersigned will indemnify, defend, and hold Wendy Lou, and their shareholders, directors, agents, employees, invitees, licensees, or visitors (collectively, "indemnified parties") harmless against all claims, damages, and costs (collectively, "claims") incurred by or alleged against indemnified parties and arising out of or relating to any act or omission of the undersigned or any of the undersigned's guests, companions, spouses, children, agents, employees, contractors, licensees, or visitors (collectively, "hunter") while at Wendy Lou, or while engaged in any activities with Wendy Lou, including any claims based upon (A) injury to or death of any person(s), (B) damage to or loss of property, (C) failure of hunter to comply with any applicable laws or the conditions of his hunt, or (D) the use by hunter, of the facilities provided by Wendy Lou.

3. *Release:* The undersigned waives all claims against indemnified parties and releases indemnified parties from any liability, based on any (A) injury to or death of hunter or (B) damage to or loss of any property belonging to hunter.

4. ***Negligence of indemnified parties:* The foregoing indemnifies, waivers, and releases will apply even if the incident giving rise to the claim is caused in whole or in part by the condition of the premises, fixtures, equipment, vehicles or other property of the indemnified parties, or by the sole or concurrent ordinary negligence or indemnified parties (but not the gross negligence or willful misconduct of indemnified parties) this waiver is unconditional and given both in my personal capacity and my capacity as a parent or guardian, as the case may be, or any minor concerned. The foregoing indemnities, waivers, and releases apply regardless of whether the incident giving rise to the claim arises out of hunting activities, other recreational activities, lodging, meals, or transportation to, from or upon the property of Wendy Lou.**

5. I accept full responsibility for any damages or loss caused by me, or my family, or any of my invitees, to Wendy Lou, its furniture, equipment and appurtenances, and I hereby indemnify Wendy Lou against such damages or loss. I hereby authorize Wendy Lou to debit my credit card with the expense of the rectifying such damages or replacing such loss.
